The requirement is that the recipient must use the membership. It is not redeemable for cash under any circumstances. The user must be at least 6 years old but not older than 18 at the time the gift is to be used.

Dates for submission of applications begins May 15, 2018 to June 30, 2018. The awarding of the giveaway will be announced August 15, 2018.

Rules and Limitations

1. How to Enter

Submit an application with a statement of 200 words or less about yourself or the nominee setting forth the reasons the nominated person is entitled to be eligible for this gift. All applications must be submitted within the stated time period, and upon receipt shall become property of the Community Character Coalition of Elk Grove.

Community Character Coalition or Elk Grove will not be responsible for delays or non-delivery by the United States Postal Service and any applications that has been tampered with will be deemed void.

2. Eligibility

All nominated persons must be residents of the corporate limits of Elk Grove Village.

Members of the Community Character Coalition of Elk Grove and their immediate families are not eligible to participate.

Only one gift will be awarded to the nominee selected by the panel.

The panel will select the winning nominee from all eligible applications. The decisions made by the panel will be deemed final.

Only one entry per person or family will be accepted.

3. Miscellaneous

All participants waive any and all claims of liability against the Community Character Coalition of Elk Grove and or its members, the American Tiger Karate Academy and its owner donating this gift and, the panel selected to judge the applications from any claims, injury or loss whatsoever nature which may be occasioned from the conduct of or participation in this giveaway program.

Any valuation of the Karate lessons will be based on available information and the value may be reported for tax purposes as required by law. The chosen nominee is solely responsible for reporting and paying all applicable taxes, which may result from this giveaway program.

Community Character Coalition of Elk Grove reserves the right to disqualify any nominee, including the chosen nominee, and may refuse to proceed with causing the Karate giveaway to any person who is ineligible or who has violated any rule, gained an unfair advantage in participating or committed any type of fraudulent conduct.

The Chosen nominee will be contacted at the address and or phone number submitted on the application. Should such notification fail for whatever reason and after all reasonable efforts of contact have been made within 10 days from the date of the announced selection, the winning application will be deemed forfeited and a successor nominee will be selected by the panel.
